

TERMS & CONDITIONS OF TICKET SALE

1. This seminar ("**Event**") is organised and promoted by weddingsmalaysia.com sdn bhd ("**Promoter**").
2. The wedding hub and The Budget Bride Sdn Bhd have been appointed as the ticketing agents (collectively "**Ticketing Agents**") for and on behalf of the promoter ("**Promoter**") responsible for the event for which they are sold ("**Event**") and/or the venue management or owner ("**Venue Owner**") responsible for the venue in which the event will be held ("**Venue**"). By purchasing the tickets you agree, on your own behalf and as agent on behalf of all persons for whom you are purchasing tickets or who will be holding tickets purchased by you (you and each such person being a "**Ticket Holder**"), to be bound by these Terms and Conditions.
3. The Promoter and its appointed Ticketing Agents have no control over the maintenance or management of the Venue. The Promoter, its agents and employees shall not be liable for any death, personal injury, loss or damage however caused while in the venue nor are they liable for any complaints, claims, refunds, or exchange for any reason whatsoever, including without limitation but subject to Conditions (7) - (10) below, cancellation or postponement of the Event. Any refunds shall be made only at the Promoter's discretion and on the Promoter's account.
4. No exchange of tickets will be made under any circumstances and tickets are not transferable.
5. No refund on tickets will be made under any circumstances except pursuant to Conditions (7) - (10) below.
6. The Promoter and its Ticketing Agent(s) will not be responsible for any lost ticket by Ticket Holder.
7. If an Event is postponed or cancelled, a Postponement Publicity Notice or a Cancellation Publicity Notice (collectively, the "**Notices**" or individually, a "**Notice**") respectively shall be posted on the weddingsmalaysia.com website by the Promoter.
8. The Venue shall at its own discretion place notices advising procedures for requesting a refund and the period and time within which the Ticket Holder could request a refund. The Promoter shall also place a notice advising procedure for requesting a refund via its website weddingsmalaysia.com.
9. No refund will be made if the request for the refund is made after three months from the date of a Notice. Such unrefunded sums shall be dealt with at Promoter's sole discretion.
10. If an Event is postponed or cancelled, refunds can be made at either at the Wedding Hub (B-08-3A, Block B, 3 Two Square, Jalan 19/1, 46300 Petaling Jaya, Tel: 60 3 7960 6480) or at Budget Brides (No. 21-1, Jalan PJU 5/21, The Strand, Kota Damansara, 47810 Petaling Jaya, Tel: 60 3 6142 6818) office during their regular operating hours. Ticket Holders will have to produce the full stub of the original tickets in good condition to claim refunds. The identity of the person receiving the refunds may be recorded by the Ticketing Agents.
11. Entry will be refused if tickets have not been purchased from Promoter's appointed Ticketing Agents or other authorised points of sale.
12. The resale of tickets at the same or any price in excess of the initial purchase price is prohibited. The Promoter and its Ticketing Agents reserves the right to cancel any tickets that have been resold and to deny any such Ticket Holder entry.
13. Entry to the Venue will be subject to the Venue's prevailing terms and conditions of entry.
14. The Promoter/Venue Owner reserves the right without refund or compensation to refuse admission/evict any person(s) whose conduct is disorderly or inappropriate or who poses a threat to security, or to the enjoyment of the Event by others.
15. No photography, audio or video recording is allowed during the Event unless otherwise stated by the Promoter.

16. The Promoter may add, withdraw or substitute speakers and/or vary advertised contents/programmes, Event times, seating arrangements and audience capacity due to circumstances beyond his reasonable control without prior notice.
17. The Promoter/Venue Owner may use the Ticket Holder's image or likeness in any live or recorded video display, photograph, picture or publicity material or website.
18. The Promoter/Venue Owner may postpone, cancel, interrupt or stop the Event due to adverse weather, dangerous situations, or any other causes beyond his reasonable control.
19. The Ticket Holder agrees to submit to any search for any prohibited items including but not limited to weapons, controlled, dangerous and illegal substances and recording devices at the venue by the Venue Owner.
20. The Ticket Holder voluntarily assumes all risk and danger incidental to the Event whether occurring prior to, during or subsequent to the actual Event, including any death, personal injury, loss, damage or liability.
21. Any complaints regarding the Event shall be directed solely to and dealt with by the Promoter. Any complaints regarding the Venue shall be directed solely to and dealt with by the Venue Owner.
22. Malaysian law shall govern the sale of all tickets and you agree to submit to the exclusive jurisdiction of the Malaysian courts.
